1) Call to order

3) <u>Communication with Administration</u>

- a) Report from the President
 - 1) Ashley Cinemas Board of Regents recently recommended \$1.3M in design money for VSU for new Performing Arts Center at the old Ashley Cinemas. It was decided in consultation with a design company to raze the building and rebuild rather than renovate (due to issues with the existing structure). The total price tag for the project is expected to be \$18M. We will get \$5M in donations (already have secured \$1.7M) and the state will put in the remaining \$13M (if fully approved). The new building would face Ashley Street (to create new frontage on Ashley) and will include a 350 seat proscenium stage and a black box arena.
 - 2) Convocation Update on the information gathered at convocation. Over 200 ideas were submitted by faculty and staff and these were streamlined into 12 major themes. The president's office will be reaching out to faculty and staff soon to see who is interested in serving on committees to discuss and implement the ideas.
 - **3)** Wear red on Fridays has taken off across campus. Dr. Carvajal will start giving out freebies to those faculty and staff he sees wearing their red on Fridays.

- a) Jacob Bell, SGA President 2018-2019 introduced himself to COSA and indicated his strong interest in and excitement about working with staff and faculty this year to make VSU even better than it already is.
- **b)** Dr. John Wright, Associate Director of Student Life, reminded everyone about Homecoming Week (October 15-20, 2018) and encouraged employees to be involved through door decorations, poster displays, attending or participating in the Parade on Saturday of that week.
