Course Goal:

This course is designed to introduce students to a variety of disabilities and assistive technologies with a focus on print disabilities. Students will develop a familiarity with the Americans with Disabilities Act, The Technology Assistance Act and other disability legislation.

Course Objectives:

Students will accomplish the following objectives in this course:

- 1. Complete an ADA compliance audit for a library.
- 2. Develop a disability services policy manual for a library.
- 3. Write a brief proposal to obtain funding for an assistive device or service.

Outcomes:

Students will gain an understanding of print disability issues and the special services that school, academic and public libraries can offer to assist patrons with special needs. Students will learn about the ADA and other legislation concerning patrons with special needs, how to develop ADA compliant plans and policies, and how to obtain funding for assistive technologies.

Course Requirements & Evaluation:

Class participation - 25% (Students should participate in weekly course readings and discussions)

Students will complete an ADA compliance audit for a library using a checklist provided by the instructor. -25%

Students will develop a disability services policies for a library. –25%

Students will write a brief proposal to obtain funding for an assistive device or service. -25%
