#### **Required Text:**

Introduction to Public Librarianship by Kathleen de la Pena McCook, New York, Neal-Schuman, 2004.

This course offers a critical examination of public librarianship. It also covers the role of state and federal government in library development. Community building as an important activity for all public librarians is an emphasis.

#### The course will cover:

- 1. The history of public librarianship within the broader historical and cultural movements of the times.
- 2. The landmark literature of the field's development.
- 3. The evolution of standards and planning for public library service.
- 4. The role of the political process in the growth of libraries and library services.
- 5. Public libraries' adult and youth services as reflections of changing societal trends.
- 6. The current status of library services and the tools for evaluating and describing services.
- 7. The overarching ideas, principles, and goals that drive public librarianship and the necessity of continuing to work towards these goals.

#### **COURSE GOALS**

- · To understand the history and philosophy of U.S. public librarianship
- To identify library services in the context of community building and comprehensive community initiatives.
- · To examine the political process as it impacts on library development
- · To analyze the role of state library agencies vis-à-vis public libraries
