Prerequisite: MLIS 7300 or MLIS 7400 or consent of the instructor. Policies and procedures for managing electronic information resources as part of a library collection. Selection, budgeting, acquisitions, cataloging, assessment, copyright, licensing, and preservation are considered.

## **Course Objectives**

At the conclusion of the course, the student will be able to:

- 1. Discuss policy alternatives and applicable procedures for selecting, acquiring, cataloging, and assessing library materials in electronic formats.
- 2. Design workable budget scenarios for library collections that include electronic formats.
- 3. Contribute to decision-making and negotiation of licensing agreements for electronic resources.
- 4. Identify and implement appropriate preservation measures for electronic resources.
